



## Green Built Homes, Verifiers Application

Interested in becoming an accredited verifier for the Green Built Homes program? The process for prospective verifiers is outlined below. Verifiers must meet these eligibility prerequisite qualifications:

- Maintain an appropriate knowledge base and skill sets to comply with the Green Built Homes Building Guidelines. This is accomplished by meeting **one or more** of the following:
  - 1 year of professional experience in green building practices.
  - Designation by NAHB as a Certified Green Professional.
  - Professional certification from Green Advantage.
  - NARI Green Building Certification from National Association of the Remodelers Industry (NARI).
  - RESNET Green Rater Certification.
  - LEED Accredited Professional Certification.
  - 12 hours of approved training.

### Once eligibility requirements are met, an individual must:

- Complete and sign the **GBH Verifiers Application** which is included here, and submit prior to attending the Verifiers Training.
- Complete the Verifiers Training.
- Pass the Verifiers Accreditation Test.
- Complete and sign the Verifiers Participation Agreement Form and submit the Verifiers Accreditation and Listing Fee.

The accreditation test can be taken the same day as the verifiers training and will be available immediately following the training or can be taken at a later date.

Certified Verifiers are required to:

- Maintain appropriate records and be available to answer auditor questions during random audits.
- Submit proof of required insurance coverage including general liability, automobile liability, workers compensation, and professional liability.
- Submit a yearly accreditation and listing fee and
- Attend 6 hours of continuing training annually.

Verifiers may work for organizations but are accredited on an individual basis.
